We find that our best CITs are those who genuinely wish to be at camp, not those who are there because their parents make them do it.

Our Counselor in Training Program is designed to offer motivated and enthusiastic young people an opportunity to prepare for positions as camp counselors. Emphasis is placed upon developing a good work ethic, being proactive in a work environment, leadership skills, and sensitivity to children's needs. CITs are still classified as campers, but have additional leadership roles and responsibilities.

Because we always experience high interest in our CIT program and space is limited, not everyone who applies will be accepted into the program. CITs will be selected based primarily, but not exclusively, on the following:

- *Attention to following deadlines and guidelines for applications (applicants must fill out their own applications)
- *Past history with our camp
